



Tuition Payment

Tuition payments are due the 1st of the month.

A \$25 late fee will be assessed on all payments received after the 5th of the month.

Tuition Assumptions

Payments include a reserved weekly time slot that works like rent one would pay for an apartment. Your monthly tuition reserves you a weekly time slot and membership within the studio whether you choose to attend or miss.

It is a flat monthly rate. Fees are charged by the month, and are not lowered nor refunded for missed lessons. Please bear in mind that, during the year, some months will contain an extra week for which there is no additional charge.

Studio Cancellations

30 days notice is required if a student decided to discontinue lessons.

Any lesson that I have to cancel will be rescheduled or refunded.

We do not offer makeup lessons.

There is no refund or credit for missed lessons.

Please understand that the tuition you pay reserves an exclusive weekly time in the schedule for your lesson.

We cannot resell that time nor can we create extra teaching time in which to give lessons.

A non-refundable **enrollment fee of \$50** per student is due every year on September 1. This fee covers the cost of group materials, studio lending books, and technology.

Monthly rates for weekly lessons (3-5 lessons per month)

30 minutes \$140 per month

45 minutes \$210 per month

60 minutes \$280 per month

A **one-hour session** outside of a recurring monthly contract is \$90 per hour.

The **studio will be closed** on the following holidays, dates and tuition is accounted for in these breaks:

Thanksgiving Thursday & Friday • Last week of December • New Year's Day • Spring Break • Fourth of July • Memorial Day • Labor Day•

Please **park** in front of the studio. No children other than siblings may attend lessons. Students who are **late for a lesson** cannot be guaranteed their full lesson time.

Please wait until your lesson time to **enter the studio**. An early arrival (or late arrival!) is a **disruption** to other students.
